Mindful of decree n°2015/374 of 12th August 2015 creating, organizing and functioning of the Limbe Nautical Arts and Fisheries Institute;

Mindful of decree n°2019/002 of 04th January 2019 to reshuffle the Government;

Mindful of order n°20 – 0106/MINESUP/SG/DAUQ/SDEAC of 17 March 2020 fixing the calendar of the competitive entrance examinations into the Cameroon State Universities and Higher Institution under the Academic Supervision of MINESUP for the 2020/2021 academic year.

#### **HEREBY ORDERS:**

Article 1: A competitive entrance examination into year one of the first cycle for the University Technology Diploma of Industrial Fishing (Fishing-Navigation and Vessel equipment), Marine engineering (Maintenance of Ships, Nautical and Industrial Equipment), Aquaculture and Fisheries Technology of the Limbe Nautical Arts and Fisheries Institute (LINAFI), for the 2020/2021 academic has been launched.

Article 2: The programs, number of places and centers for the competitive entrance examination are as shown in the table below:

Article 3: The written part will take place on the 26th and 27th September 2020 in the following centers: Douala, Limbe, Garoua, and Yaoundé.

Article 4: The orals for successful candidates will take place on the 6th and 7th October 2020 in the Limbe centre exclusively.

## Article 5: Conditions to fulfill:

The competitive entrance examination is opened to Cameroonians of both sexes who are holders of the following certificates: GCE Advanced Level in at least two (2) sciences papers, Baccalauréat C, D, E, F, Brevet de Technicies Industriel besides ITH. Any other equivalent certificate recognized by the Ministry of Higher Education is accepted.

- Those awaiting results are eligible to apply.
- The age limit for candidates is between: \*
- ✓ 18 and 35 years, for Industrial Fishing and Marine Engineering.
- √ 18 and 40 years, for Aquaculture and Fisheries Technology.

# Article 6: Application file

The application file shall comprise the following documents:

- A registration form should be collected from the Institute of LINAFI, all the Regional Delegations of the Ministry of Livestock, Fisheries and Animal Industries, or could be downloaded at the MINESUP website <a href="http://www.minesup.gov.cm">http://www.minesup.gov.cm</a>; and MINEPIA website
- A photocopy of national identity card or receipt;
- A certified true copy of the Birth Certificates dated not more than three (03) months;
- A certified true copy of the corresponding certificates dated not more than three (03) months;
- A certified true copy of non-conviction dated not more than three (03) months;
- Two passeports size photographs;
- An authorization to sit for examination issued by the user ministry (for civil servant);
- A medical certificate issued by a medical officer from the administration and testifying that the candidate is physically and mentally fit for the sea profession;
  - One self-addressed A4 envelope bearing a stamp of 500 CFA;
- A receipt upon payment of twenty thousand (20.000) CFA as registration fees delivered by BICEC
   BANK to be deposited on account N° 10001068406351014000104.

NB: Not other form of payment is accepted.

Complete files should be submitted either at LINAFI Limbe or at any of the ten (10) Regional Delegations of the Ministry of Livestock, Fisheries and Animal Industries latest on Friday, the 25th September 2020 at 3.30pm prompt.

#### FEES:

A. Tuition: 500 000 FCFA

B. Lodging: 100 000 FCFA

C. Feeding: 405 000 FCFA

In addition, the cost of five (05) basic STCW obligatory certificates to facilitate access to sea going vessels will be borne by the students.

Article 7: Under the same academic requirements, foreign candidates are authorized to submit their files. Their selection will be based on the study of their academic files, physical and medical tests in conformity with the regulation in force.

Article 8: Only candidates who submit their application files on will be allowed to take the competitive entrance examination. They should be at the examination center at least 30 minutes before the start of each paper bringing along their National Identity Card.
