#### HEREBY ORDER

<u>Article 1:</u> A competitive entrance examination into year one of the first cycle for the University Technology Diploma of deep sea Fishing (Fisheries Lieutenant), Marine Engineering (class 3 officer unlimited), Fisheries Technology and Aquaculture of the Limbe Nautical Arts and Fisheries Institute (LINAFI), for the 2018/2019 academic year is organized in the following centres: Douala, Garoua, Limbe and Yaoundé.

## Article 5: CONDITIONS TO FULFIL

The competitive entrance examination is opened to Cameroonians of both sexes who are holders of the following certificates: GCE A level in at least two (2) papers in sciences subjects. Baccalaureat C, D, E, F or any other equivalent certificate recognised by the Ministry of Higher Education. The age limit for candidates is between 17 to 30 years as from the 1<sup>st</sup> of January 2018.

<u>Article 6:</u>Under the same academic requirements, foreign candidates are authorised to submit their files. Their selection will be based on the study of their academic files, physical and medical tests in conformity with the regulation in force.

# Article 7: APPLICATION FILE

The application file shall comprise the following:

A registration form to be collected from the institute or its website www.linafi.cm,

- 2) A certified true copy of the Birth Certificates dated not more than three (03) months;
- 3) A photocopy of national identity card or its receipt;
- 4) A certified true copy of the corresponding Certificates dated not more than three(03) months;
- 5) A certified true copy of non-conviction dated not more than three (03) months;
- 6) A medical certificate issued by a medical officer from the administration and testifying that the candidate is physically and mentally fit for sea profession.
- 7) A receipt upon payment of twenty thousand (20.000) CFA as registration fees delivered by BICEC BANK to be deposited on ACCOUNT N° 10001 068406351014000104.

#### No other form of payment is accepted.

- 8) Two passport size photographs.
- 9) An authorization to sit for examination issued by the user ministry (for civil servants).
- 10) One self-addressed A4 envelope bearing stamped (s) of 500 CFA;
